1. It is proposed to conduct General Departmental Competitive Examination for filling 96 posts of Goods Guard in Pay Matrix Level-5 (PB Rs.5200 – 20200 + GP Rs.2800) of VII CPC under GDCE scheme. The GDCE will be conducted by Railway Recruitment Cell, Chennai.
2. The break-up of vacancies for which GDCE/Goods Guard is to be conducted are as under:-

3. ELIGIBILITY CRITERIA

3.1 Zone of Consideration: Only serving regular Railway employees of Southern Railway and ICF who are working in the Pay Matrix Level 5 and below of 7th CPC (Excluding MACP) (GP below Rs.4200/-) are eligible to apply in terms of Railway Board's letter No.E(NG)I-2008/PM1/6 Part, dtd.24.07.2017 (RBE No.72/2017). RPF/RPSF Personnel are not eligible to apply in terms of Railway Board's letter No.E(NG)I/2002/PM2/9, dtd.11.08.2003 (RBE No.139/2003).

3.2 Educational Qualification: Candidates should possess qualification of DEGREE (10+2+3 stream) from the recognized Board/University/Institute as on the date of Notification.

4. Age : Maximum age limit as on **01.07 .2019:**

5. Volunteers who fulfil all requirements and are working in the Departments/Branches of Headquarters/Divisions/Extra Divisions/Production Units/Construction Units of Southern Railway and ICF/PER may apply.

6. (a) All columns of the application in prescribed format should be duly filled and the same should be verified and certified in the appropriate column by the concerned Supervisory Official. The applications without Supervisor's certification will be rejected.
- (b) The eligible employees should send their application by ordinary post in the prescribed format directly to RRC/Chennai to the address mentioned below by post or in person **on or before 01/04/2019 at 17.00 hrs.**

The last date and time for receipt of application is “SACROSANCT”. No need to attach the attested copies of certificates in proof of their passing Degree (10+2+3) or other qualification as mentioned above and community certificate in the case of SC/ST/OBC, which will be called and verified after the written examination.

- (c) The applications received will be treated as “invalid/ineligible” on the following grounds:
- 1) Applications not in the prescribed format/missing columns.
 - 2) Incomplete/ineligible applications.
 - 3) Applications unsigned/signed in capital letter.
 - 4) Applications with LTI not affixed/blurred/smudged.
 - 5) Applications of over-aged candidates.
 - 6) Applications received after closing date.
 - 7) Applications without verification and certification of Supervisory official.

7. The employees who are selected are liable to be posted to any Division of Southern Railway. Those who are not willing for posting involving transfer, need not apply.

The allotment of Division of the selected candidates/employees will be at the discretion of the administration, subject to availability of GDCE quota vacancies. Applicant has no right to ask the Division of their choice.

8. The GDCE will consist of Written Examination, Verification of certificates and Medical Examination. The standard of the Written Examination under GDCE shall be that of the Written Examination prescribed for Direct Recruitment.

9. Candidates who are shortlisted should bring a "Vision Certificate" in the prescribed format from an Ophthalmologist at the time of Document verification.
10. Candidates may note that they will be empanelled based on their performance in the written examination/Computer Based Test (CBT). Those empanelled will be subjected to Medical Examination and only those who are found fit in the Medical classification of "**AYE TWO**" shall be considered for appointment.
11. The employees selected for appointment as Goods Guard on the basis of GDCE are required to undergo prescribed mandatory training and pass the test held at the end of the training, before absorption against working post.
12. The Notification may be given wide publicity by circulating to all concerned by notifying the same to avoid complaints of non-circulation of this notification.
