Based on the performance of candidates in the Computer Based Test (CBT) exam conducted during the period 17-08-2022 to 11-10-2022 by Railway Recruitment Boards(RRBs) and qualifying in Physical Efficiency Test (PET) for Non-PwBD & Non-CCAA candidates conducted from 19-01-2023 to 23-01-2023 for the Posts in Level-1 of 7th CPC Pay Matrix against Centralised Employment Notice- CEN RRC 01/2019, candidates, listed hereinunder are provisionally shortlisted to appear in the 7th Document Verification of Original Certificates (DV) & Medical Examination (ME) against **Replacement** vacancies, as per the Schedule given below. Candidates equal to the community wise total Replacement vacancies for the Railway Recruitment Cell(RRC) Chennai, have been shortlisted for the 7th DV & ME.

The candidature of all the shortlisted candidates for 7th DV & ME is purely provisional and is liable to be cancelled, at any stage of recruitment or thereafter, in case of any inconsistency/deficiency in the data furnished by them in their online application or any malpractice on the part of candidates coming to the notice of RRBs/RRCs at any stage of the recruitment process.

It may be noted that merely calling a candidate for 7th DV & ME does not entitle him/her in any way to an appointment in the Railways. The shortlisted candidates are advised to regularly visit the official websites of RRC/Chennai www.rrcmas.in for the updates.

While every care has been taken in preparing the list of candidates shortlisted for 7th DV & ME, RRB/RRC reserve the right to rectify any inadvertent error or typographical/printing mistakes. RRB/RRC regret inability to entertain any correspondence from candidates who have not been shortlisted.

The Roll Numbers of the provisionally shortlisted candidates for 7th DV & ME are not in order of merit.

The provisionally shortlisted candidates for 7th DV & ME may also note that requests for change of DV & ME Date/Venue/Time will not be entertained under any circumstances.

Call Letters indicating Date, Time & Details of Venue of 7th DV & ME along with detailed Instructions will be available for download in this Website (www.rrcmas.in) in due course.

Following documents in original as well as two photocopy of each are required to be produced for varication:

8.1

Lower portion of call letter, issued to candidates during CBT and PET (PWBD candidate must bring lower portion call letter of CBT)

8.2

Age proof certificate such as 10th/Matric/Birth Certificate/School Certificate indicating Date of Birth.

8.3

Valid Photo Identity like Aadhaar Card, Voter Card, Pan Card, Driving License or Passport.

8.4

10th/Matric Pass Certificate as proof of Educational Qualification.

8.5

SC/ST/OBC candidates should produce valid Caste Certificate from competent authority. OBC Certificate for OBC candidate should not be older than 01 (one) year from the date of DV and in proper format (Annexure II of CEN RRC-01/2019) mentioning that the candidate does not belong to Creamy Layer. OBC Candidate will have to produce self declaration in prescribed format (Annexure II A of CEN RRC-01/2019).

- 8.6 Economically Weaker Section (EWS) candidates, if opted in the application, should produce income certificate in the prescribed format (Annexure III of CEN RRC-01/2019) issued by the Competent Authority.
- 8.7 Economically Backward Class (EBC) Certificate in proforma issued by Competent authority (Annexure III A of CEN RRC-01/2019) for waiver of Examination fee, if claimed while applying against the CEN.
- 8.8 Self – Declaration for Waiver of Examination Fee in non-judicial stamp paper by candidates belongs to Minority Community (Annexure IV of CEN RRC-01/2019), if claimed while applying against CEN.
- 8.9 PWBD candidates should bring their disability certificate in the format as mentioned in the notification CEN RRC-01/2019 [Annexure – V(A),V(B), V(C), V(D)]
- 8.10 Any other relevant document, required as per instructions in CEN RRC-01/2019.
- 8.11 Serving Govt/PSU Employees to submit NOC as per Para 18.4 (12) of CEN RRC-01/2019.
- 8.12 Any other documents mentioned by the candidate in the CBT application form.
- 8.13 Three Passport size photographs as submitted during CBT Application (without wearing Sun Glass and caps)
- 8.14 Candidates in possession of certificates in languages other than Hindi & English should bring a translated version in English duly attested by a Gazetted Officer

9 Candidates have to pay a sum of Rs. 24/- (Rupees Twenty Four only) at the time of Document Verification towards Medical Examination fee.

10 Candidates are advised to upload Colour Photo and Signature in RRB Document Verification portal <https://oirms-ir.gov.in/rrbdv/> duly following the instructions mentioned therein. This portal will be active for uploading from 07 days prior to date of DV and closes on the date of DV.

11 Block date and Reporting Time for verification of DV & ME for absentee candidates is 24-07-2026 at 10.00 Hrs at the same Venue of the Original Date of DV & ME. It must be noted that failure to report for the Document Verification on the scheduled date will tantamount to rejection of candidature unless it is supported by documentary evidence that the candidate had to appear in a University/Government examination or due to sickness of the candidate. No other reason for absence will be considered. No fresh e-call letter will be issued.

12 In terms of Rule 5 of the Aadhaar Authentication for Good Governance (Social Welfare, Innovation, Knowledge) Rules, 2020 read with Section 4(4)(b)(ii) of the Aadhaar Act, 2016 (as amended), the Railway Recruitment Boards are allowed to perform Aadhaar Authentication, on voluntary basis, for establishing identity of each candidate to avoid impersonation and other malpractices during the examination and to ensure fair conduct of examination. Accordingly, Aadhaar based Biometric Authentication of candidates will be carried out before/during course of Document Verification (DV). Candidates are required to bring their original Aadhaar Card.
