2.2. Service Condition: All the serving erstwhile Group-D employees of ICF having cadre status in Level-1 working in all departments except RPF/RPSF who fulfill the prescribed age and educational qualification are eligible to volunteer for the above General Departmental Competitive Examination.

2.3. In terms of Railway Board's letter No.E(NG) 1/2005/PM/2/3 dated 04.03.2005, the staff working in Zonal Railways are not eligible to apply for the posts notified by ICF through GDCE.

Educational qualification: In terms of RBE No.145/2014, the prescribed educational qualification for the post of Junior Clerk-cum-Typist is 12th (+2 stage) or its equivalent with not less than 50% of marks in the aggregate. 50% marks is not to be insisted upon in the case of SC/ST/Ex-servicemen and for candidates who are Graduates.

3. Selection procedure:

The GDCE will consist of Written/Computer based test followed by Typing skill test, verification of original certificates and medical examination. The standard of written/Computer based test under GDCE shall be that of the written/Computer based test prescribed for direct recruitment. The written/Computer based test and Typing Test will be conducted by RRC, Chennai.

Based on performance in the CBT, candidates at a ratio of 1:8 will be called for Typing Skill Test of 30 wpm in English/25 wpm in Hindi on Computer.

The question paper for CBT will in Trilingual i.e Hindi, English and Tamil.

Empanelled candidates will be examined for fitness in the appropriate medical classification, if not already done and should be found fit in medical classification as prescribed before they are directed for training.

4. Training: Selected candidates will have to undergo induction training for a period of 21 days as required under extant rules.

5. General Conditions:

i. Before applying for the post, the candidates should ensure that he/she fulfills all the eligible norms including the community requirements of the post.

ii. At the time of applying, candidates should possess the prescribed minimum educational qualification. Final/Provisional certificates issued by the competent authority along with copies of all marks sheets only will be considered. Those awaiting result of the final examination need not apply.

iii. Candidates trying to use influence or unfair means will be disqualified from the selection at any stage. RRC will reject any application at any stage of selection process if the candidate is ineligible for the post for which he/she has applied or indulges in any form of malpractice. Even after appointment such candidate is liable to be summarily removed from service.

iv. Candidates attempting to give false information/suppress facts, attempt impersonation/fraudulence will be disqualified and are liable for debarment and/or disciplinary action even after selection.

v. Even after qualifying in the examination if it is found that he/she is not eligible as per conditions prescribed in the notification, his/her candidature will be cancelled and they will not be considered for empanelment.

vi. By virtue of qualifying the examination, it would not confer any right to the candidates for being placed in the panel subject to fulfillment of eligibility conditions such as service condition, parent cadre, age, qualification, etc.,

vii. In terms of Railway Board's letter No. 2010(E) (RRB) 25/27/Pt dated: 09.06.2011, wherever any question(s) or answer(s) in the question paper is/are found to be incorrect, the question(s) would be omitted from the scope of evaluation. The marks obtained for the remaining questions will be considered for evaluation proportionately equated to the total marks.
