2.2. Service Condition: All the serving regular Group-C employees including Level-1 of ICF working in all departments (except RPF/RPSF) who fulfill the prescribed age and educational qualification are eligible to apply for the above General Departmental Competitive Examination. 2.3.Educational qualification: The candidates should possess the qualification prescribed for recruitment to the post as under:

3. Selection procedure:

The GDCE will consist of Computer Based Test followed by Document verification and medical examination. The standard of Computer Based Test under GDCE shall be that of the Computer Based Test prescribed for Direct Recruitment Quota on open competition for this post. The Computer Based Test will be conducted by RRC, Chennai.

Empanelled candidates will be examined for fitness in the appropriate medical classification, if not already done and should be found fit in medical classification as prescribed before they are directed for training.

- 4.Training: Selected candidates will be deputed to undergo training for a period of 12 months/52 weeks as required under extant rules. The training period may be extended or curtailed at the discretion of the administration.
- 5. Stipend: The selected employees will be eligible for stipend or their substantive cadre pay whichever is beneficial for them. Pay and allowances for Apprentice selected under GDCE will be governed by para 1905 of IREM Vol II & Railway Board's letter No.PC IV/2006/Misc/5 dtd:17/04/2006 and Railway Board's letter No.PC-V/2016/PS/I (Stipend) dtd:02/02/2017.
- 6. Execution of service agreement: Selected employees are required to execute a bond and agree to serve the Railway Administration for a period of five years after they are absorbed to their working post as Junior Engineer.

7. Absorption: On successful completion of 52 weeks training, they will be considered for absorption to the post of Junior Engineer in the respective Department to which he/she is selected in Level-6 as the case may be. No request for change of department or reversion to the parent cadre will be considered under any circumstances. No guarantee of absorption can however be given but if the Administration posted them as JE, they should accept it and should continue in the service of this Administration for a minimum period of 5 years after successful completion of their training.

8. General Conditions:

Before applying for the post, the candidates should ensure that he/she fulfills all the eligible norms including the community requirements of the post.

At the time of applying, candidates should possess the prescribed minimum educational qualification. Final/Provisional certificates issued by the competent authority along with copies of all marks sheets only will be considered. Those awaiting result of the final examination need not apply.

Candidates trying to use influence or unfair means will be disqualified from iii. the selection at any stage. RRC will reject any application at any stage of selection process if the candidate is ineligible for the post for which he/she has applied or indulges in any form of malpractice. Even after appointment such candidate is liable to be summarily removed from service.

Candidates attempting to give false information/suppress facts, attempt impersonation/fraudulence will be disqualified and are liable for debarment

and/or disciplinary action ever after selection.

In terms of Railway Board's letter No. 2010(E) (RRB) 25/27/Pt dated: 09.06.2011, wherever any question(s) or answer(s) in the question paper is/are found to be incorrect, the question(s) would be omitted from the scope of evaluation. The marks obtained for the remaining questions will be considered for evaluation proportionately equated to the total marks.

- 10.1 On receipt of application through ONLINE a confirmation message will be sent to the registered mobile number of the employee available in Personnel Branch. If the SMS is not received within a day employees are advised to contact Ch.OS/S2/PB(Note: To register and update mobile number, Ch.OS/S2/PB to be contacted).
- 10.2 Employees are advised to utilize the services of Facilitation Center at both Shell and Furnishing Division.
- 10.3 If any employee possess the additional qualification, besides the qualification appearing in online portal, should submit an attested copy of the additional qualification to PB within 3 days from the date of submission of ONLINE APPLICATION. If the relevant certificate is not submitted the qualification appearing in the Service Register will be taken into consideration.
- 10.4 In terms of Railway Board's letter No.E(NG)II/2011/RR-1/11(RBE No.166/2011) dated.09/12/2011, the services rendered in 1S pay band(as Trainee Level-1) will not be counted as service.

The last date and time for submission of application is upto 17.30hrs of 06/11/2024. No need to upload the attested copies of certificates as proof of passing 10th/Matric, Diploma/Degree and community certificate in the case of SC/ST/OBC which will be called and verified for the qualified candidates during document verification.

- 11. The applications submitted will be treated as" invalid/ineligible " on the following grounds;
 - i. Incomplete/ineligible applications
 - ii. Applications of overaged candidates.
- 12. The candidates may please note the following;
 - i. Only ICF employees can apply for the GDCE post of Jr.Engineer/ Mech/Elec.
 - ii. Go through the notification carefully before filling up of the application.
- iii. Ensure that you possess the prescribed Educational Qualification mentioned in the notification.
- iv. In the event of any information given in the declaration is found to be false or incorrect, your candidature will be rejected and you will be liable to be taken up under DAR for any violation of the provisions of Railway Service (Conduct) Rules.
- v. If you are selected, you will not be permitted to seek reversion back to your previous post. No representation in this regard will be entertained.
